2018 Swine Regulations

Pennsylvania Swine:

1. A Certificate of Veterinary Inspection (CVI) issued after May 1, 2018.
2. All animals must be free of evidence of infectious and contagious diseases and a statement of this should be written on the CVI.
3. Individual animal ID. ID options include the following:
 - A form of official ID, including:
 - A registration certificate in combination with an ear notch; or
 - A USDA-issued metal ear tag with a US shield ; or
 - An ISO-compliant 15-digit eartag starting with "840";

OR

 - A plastic stamped ear tag (market hogs only)

Out of State Swine:

1. Certificate of Veterinary Inspection (CVI) issued within the 30 days prior to the date of importation is required. The CVI shall include a statement verifying that the swine have not been fed raw garbage.
2. Vesicular Stomatitis (VS) Statement: This applies to states that experienced a VS outbreak in the last 12 months. In these cases an accredited veterinarian shall determine whether the animals are free from VS, and animals shall be accompanied by a CVI with the following statement signed by the accredited veterinarian: "All animals identified on this CVI have been

examined and found to be free from VS. During the past 90 days, these animals were not located within 10 miles of a site where VS has been diagnosed.”

3. All animals must be free of evidence of infectious and contagious diseases and a statement of this is required on the CVI.

4. Individual animal ID. ID options include the following:

- A form of official ID, including:
- A registration certificate in combination with an ear notch; or
- A USDA-issued metal ear tag with a US shield
- An ISO-compliant 15-digit ear tag starting with “840”

5. Brucellosis Testing Requirements:

- No brucellosis test is required if the animal originates from a validated brucellosis-free herd. If from a validated herd, the herd number and date of last test must be included on the CVI.
- If not originating from a validated herd, out of state swine must be negative to an official brucellosis test within the 30 days prior to the date of importation, and the negative results and date of test must be included on the CVI or the animal must be accompanied by a negative laboratory test report (a copy of the original lab report is acceptable).

6. Pseudorabies Testing Requirements:

- No pseudorabies test is required if the animal originates from a qualified pseudorabies-negative herd. A qualified pseudorabies-negative herd shall not be construed to mean every swine herd from a Stage V state, but only those herds in compliance with individual herd testing plans. If from a qualified herd, the herd number and date of last test must be included on the CVI.
- If not originating from a qualified herd, out of state swine must be negative to an official pseudorabies test within the 30 days prior to the date of importation, and the negative results and date of test must be included on the CVI or the animal must be accompanied by a negative laboratory test report (a copy of the original lab report is acceptable).

2018 RULES AND REGULATIONS:

ENTRY DEADLINE: Friday, July 13, 2018

ENTRY FEE: \$2.00 per animal and \$2.50 for Sow and Litter

ARRIVAL TIMES:

Breeding Swine: Thursday, July 26, 2018 - 8:00 AM to 4:00 PM

Open Carcass: Thursday, July 26, 2018 - 2:00 PM to 4:00 PM

Weigh-in for Carcass Swine: Thursday, July 26, 2018 - 5:00 PM to 5:30 PM

RELEASE TIME: Saturday, July 28, 2018 - 10:00 PM

1. To show ownership, the exhibitor's name must be on registration papers.
2. When livestock barns are filled to capacity entries will be refused based on latest postmark.
3. All pigs over 3 months of age must have papers. Registration papers will be checked at 6:00 PM on Thursday, July 26, 2018. If ear notch on pigs does not match what is on the entry, animal will not be shown.
4. No swine showing signs of injury, contagious or infectious diseases will be admitted to the show.
5. All show swine must be individually identified by ear tag, ear notch or tattoo.
6. Joint ownership considered being as one owner in accordance with registration papers.
7. Exhibitor limited to 2 premiums per class. Group classes limited to 1 entry per exhibitor.
8. 4-H'ers may enter the Open Breeding Show provided they follow the open class rules. No 4-H swine will be permitted in the Open Carcass Show.
9. All Open Carcass swine must be able to be slaughtered.
- 10. SUBSTITUTIONS PERMITTED IN SAME CLASS ONLY!**

2018 RULES AND REGULATIONS:

1. Animals will be weighed to determine class. **IF 5 OR FEWER ANIMALS ARE ENTERED, THEY WILL ALL BE SHOWN IN 1 CLASS.**
2. All animals will be slaughtered at a local packer. Exhibitor will be responsible for processing fees and picking up processed meat.
3. **A trucking fee will be assessed.**
4. **Pens to be cleaned by exhibitor.**
5. Minimum weight: 220 pounds; No maximum weight. **NO RE-WEIGHING**
6. 4-H animals **NOT** permitted.
7. Barrows and/or Gilts eligible.
